## **Dodd Reservoir: interim restoration report**

In 2014 the Denver Field Ornithologists (DFO) Board approved a grant to the Boulder County Audubon Society (BCAS) for a prairie restoration project at Dodd Reservoir, a property northeast of Boulder owned by BCAS. A field trip will be led in June 2015 to view the project. Many qualified major advisors and partners are involved in the project.

As of December 2014, the following restoration work has been completed at Dodd Reservoir:

- 2.5 acres of smooth brome have been eradicated in native grass restoration area;
- 2.5 acres were planted to cover crop of milo in 2013;
- 2.5 acres have been planted to native grasses and forbs;
- 300 yards of prairie dog visual barrier on west boundary;
- 150 yards of downed barbed wire and T posts removed;
- 200 yards of woven wire removed to create migration corridor;
  - 5 bird nest boxes placed around reservoir;
- 5 bee boxes placed as part of the Uni-
- versity of Colorado Bees Needs research project;
   planted 7 varieties of fruiting shrubs and native willow;
- joined research study with Colorado Department of Agriculture for 2-year trials of bio-control on Canada thistle with (1) Canada thistle stem gall fly *Urophora cardui* and (2) rust fungus *Puccinia punctiformis*; and
- completed the following monitoring studies: pre-restoration (1) total bird counts 2009–2011 (1,992), (2) botanical inventory of plant issues and assets, and (3) bird, butterfly, and dragonfly transect surveys.

As of January 2015, the following restoration work will continue:

• partner with Wildland Restoration Volunteers to remove crack willow and Russian olive;

- mow native restoration area yearly and over-seed low-yielding areas;
- continue with weed control in wetland and south shore; and
- post-restoration monitoring studies, total bird counts, botanical inventory, and bird, butterfly, and dragonfly transect surveys.
